Please be advised your request to hold an 18-hole event at Foxfire Golf Club, on The Players Club Course, has been approved, subject to the following conditions and your acceptance of this contract.

1. SHOTGUN STARTS ARE DONE MONDAY- FRIDAY WITH A MINIMUM OF 40 GOLFERS. SHOTGUN STARTS ON WEEKENDS REQUIRE 100 PLAYERS.
2. Green fees with riding cart will be based on the current greens fees at \_\_\_\_\_ per player. Carts will be leased only to golfer. Driving Range is included.
3. All food and beverages consumed on Foxfire premises must be purchased from Foxfire, an 18% gratuity and a 7.25% sales tax will be assessed on all food and beverages. Outside catering requests may be approved with a \$3 per person clean-up fee assessed.
4. Any items brought to Foxfire as donations (i.e. water) must be passed out only to participants and not sold for profit.
5. The Ohio Liquor Control Laws prohibit any beer, wine, liquor, or alcohol of any sort being brought to Foxfire, given away at Foxfire or sold at Foxfire. If any alcohol is found or seen during your event, it will be confiscated.
6. If you would like to reserve tent, tables and/or chairs at an additional fee, to be set-up for your event on the driving range, Foxfire Golf Club must be notified 90 days prior to the event. If for some reason the tent must be cancelled, you must notify Foxfire no later than 30 Business Days prior to the event; otherwise, you will be charged half of the cost of the total tent package (tent company policy).
7. A 10% discount will be offered on all non-sale items in the pro shop.
8. A guaranteed number of golfers must be received 7 days in advance for weekday outings, and 14 days in advances for weekend outings. The confirmed number is the number you will be billed unless actual count is greater. This applies to both golf and dinner. Final count is due to the course on date: \_\_\_\_\_.
9. A minimum of 40 guests is required for use of the banquet room/banquet meal. If fewer than 40 guests are confirmed, you will be billed for 40 unless actual count is greater.
10. All golf outings will be played rain or shine, unless the course is closed. The golf professional will determine if the course is playable if weather is inclement. If the course does close, rain checks will be distributed or a rain date will be determined.
11. Only Foxfire employees are permitted to drive the beverage cart.
12. Payment in full for the outing MUST be made on the day of the event. Money order or checks are preferred. However, for an additional 3% charge, we will accept MasterCard, Visa, or American Express.
13. There will be no extra golf carts given or leased to non-golfing participants, unless driver is approved. Any extra carts needed will cost \$20 per cart and will be added onto your invoice if not paid for at the time of use.
14. The Outing/Event will be held responsible for any Cart Damage that is a result of any member of the Outing/Event.

Outing dates will be secured upon receipt of a signed contract and a \$200.00 deposit. Contracts must be returned to Foxfire within ten days of receipt. Deposit will be applied to the final bill. In the event of a cancellation, the deposit is non-refundable.

I agree to hold Foxfire harmless and to defend it from any and all claims for damages of any nature whether to myself or to others that may arise from this agreement. The person signing this agreement is responsible for payment of all fees or damages incurred by the organization.
